

#### New Law in Tennessee regarding Domestic Violence

Gov. Bill Lee (R-TN) signed the Debbie and Marie Domestic Violence Protection Act into law in May, which requires courts to order the most violent domestic offenders to wear a GPS tracking device "unless the court finds the offender no longer poses a threat to the alleged victim or public safety."

Under the law, victims are provided with an app or electronic receptor device that notifies them if the offender is within a certain distance of their location.

Law enforcement officers are also notified via text message and email if defendants violate the conditions of their bond.

The offender is required to pay all costs associated with both their GPS tracking device and the victim's monitoring app.

The law is named after Debbie Sisco and her daughter, Marie Varsos, who were shot and killed by Marie's estranged husband, Shaun Varsos, in 2021 while he was out on bail after strangling and threatening to shoot his wife the month before.

Previously, judges had the option to require GPS tracking as a condition of bail, but they often didn't.

Alex Youn, Sisco's son and Marie Varsos's brother, spent the following years advocating mandatory GPS tracking for aggravated assault offenders in domestic violence cases.



## Overcrowding Problem







Imagine being forced to live in a confined space without any room to breathe, personal space, or the chance to engage in constructive activities. This paints an accurate picture of the reality faced by millions of inmates across the globe due to prison overcrowding. Overcrowding in prison has become a critical issue in many countries, eroding the basic human rights of individuals and making the goal of successful rehabilitation an uphill battle. The aim of incarceration, traditionally, extends beyond mere punishment: it includes the rehabilitation of the offender.

Rehabilitation seeks to help inmates reintegrate into society post-incarceration by equipping them with useful skills and addressing behavioral issue.

However, the overcrowded conditions of prison pose severe threat to these rehabilitation efforts, creating environments that are counterproductive to the positive change that rehabilitation aims to engender. Overcrowding can lead to heightened levels of violence within prisons, creating a volatile and unsafe environment. These conditions, characterized by fear and constant tension, are not conducive to the delivery of rehabilitation programs. The constant threat of violence can distract from rehabilitative efforts making it more challenging for inmates to focus on personal growth and reform...



## Overcrowding Solution







One of the primary methods to address prison overcrowding involves reevaluating and reforming current sentencing policies. Mandatory minimums and three strike laws can contribute to an excessive prison population, with individuals serving lengthy sentences for non-violent crimes. By conducting a thorough review of these policies, governments can better align sentences with the gravity of the offense. Considering the potential for rehabilitation and public interest.

Another way to mitigate prison overcrowding involves implementing alternatives to incarceration for non-violent and first-time offenders. These may include probation, community service, restorative justice programs, and drug treatment programs. Not only do these alternatives help reduce prison populations, but they also often prove more effective in preventing recidivism by addressing the root causes of criminal behavior.

Finally, improving early release programs can contribute significantly to alleviating overcrowding. Parole, temporary releases, and earned credit programs can serve as incentives for good behavior, motivating inmates to participate in rehabilitation programs. However, these systems need to be well-managed and balanced with consideration for public safety to be truly effective. Wearing a HEM /GPS can serve as a way to help offenders with early release & time serve while be back in society being productive and with their families.






